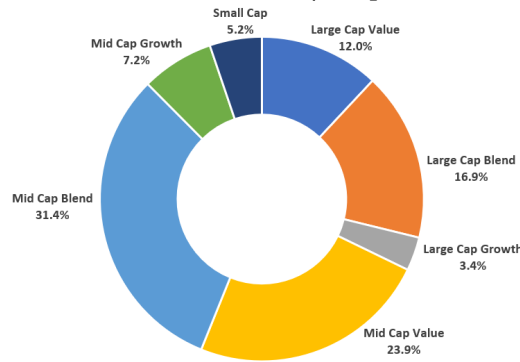

ETF Risks
