» Fund Description

» The Point Bridge America First ETF (MAGA) seeks to track the performance of the Point Bridge America First Index ("MAGA Index"), an equal-weight custom index derived from holdings in the Solactive U.S. 500 Index.


- Using a rules-based methodology, the Index selects the top 150 Republican/GOP stocks from the Solactive U.S. 500 Index based on the political contributions of the company PACs and employees during the previous two election cycles, and subsequently measures the percentage of domestic assets versus foreign assets of the companies.
- MAGA is the first ETF of its kind, providing investors with the opportunity to make investment decisions based on their Republican political beliefs

ETF Risks
